



Thank you for your request in the above-referenced case. I have reviewed my records and estimate your transcript will be 60 pages. 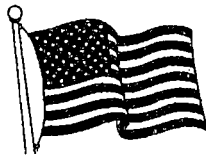
