I assume this letter was sent because of the notification the Court received in which the Court was notified that my bar membership in South Carolina was administratively suspended.



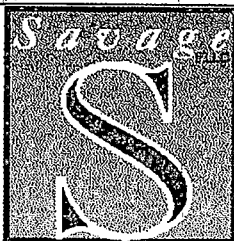
