ARMED ROBBERY

§ 16-11-0330

At a Court of General Sessions, convened on the 10th day of June, 2016, the Grand Jurors of Greenwood County present upon their oath:

That Thomas Allen Smith, on or about February 18, 2016, in Greenwood County, willfully and unlawfully while armed with a deadly weapon, or while alleging, either by action or words, he was armed while using a representation of a deadly weapon, or any object which a person present during the commission of the robbery reasonably believed to be a deadly weapon, feloniously take from the person or presence of . . . by means of force or intimidation, goods or monies described as follows: United States currency, with intent to deprive the owner, South State Bank, Inc., permanently of such property, in violation of Section 16-11-330 of the South Carolina Code of Laws, 1976, as amended.

Against the peace and dignity of the State, and contrary to the statute in such cases made and provided.
