Mental and Emotional Health

70. The defendant reported that he has never consulted with a psychiatrist or other mental health professional and described his overall mental and emotional health as good. There is no documented evidence to suggest otherwise.

Substance Abuse

71. Defendant McDaniels has a history of using marijuana, cocaine, crack cocaine, and alcohol. He noted he began using marijuana, cocaine, crack cocaine, and alcohol at the age of 15. Before his arrest for the instant offense, the defendant used alcohol, crack cocaine and cocaine on a daily basis. He noted that he used marijuana on occasions. Defendant McDaniels stated he has never received any alcohol or substance abuse counseling. An initial urinalysis test was not administered by Pretrial Services because the defendant has been in State Custody since March 2006. He stated he attended Spartanburg Alcohol and Drug Abuse Commission (SADAC) in 2004 for alcohol and drug abuse.

Information regarding participation in drug treatment and/or testing program is confidential and should not be disclosed on the public record. Pursuant to 21 U.S.C. § 1175; 42 C.F.R. § 2.39.

Educational and Vocational Skills

72. According to the defendant, he went to Driftwood Middle School in Florida where he completed the seventh (7th) grade. Defendant McDaniels stated that he received his Graduate Equivalency Diploma while incarcerated at a South Carolina Department of Corrections.

Military Service

73. None.

Employment Record

74. Defendant McDaniels is currently unemployed and reports his last employment with Florida Frame & Trim as a carpenter. The defendant earned \$13.50 per hour. This employment ended in January 2006 as a result of the defendant being arrested. Prior to this employment, defendant McDaniels reported working for numerous construction companies.

Financial Condition

75. The defendant reports no substantial financial assets or liabilities.
