



This is to acknowledge that I received your letter requesting the Transcript of Record in the above matters. I have reviewed my records and estimate that the transcript will be approximately 20 pages.

Rule 607 provides that the rate of \$.75 shall be charged per page for a copy of a transcript. Based on the current rate, the estimated cost will be \$15.00 (\$22.00 w/postage if hard copy). Upon receipt of your check in the amount of \$15.00 (to my attention at the above PO Box address), I will be able to place your request in line for transcription. If the transcript is less than 20 pages, I will refund the difference to you upon delivery of the transcript. If the transcript is more than 20 pages, the balance will be due prior to delivery of the transcript.

If you desire to cancel the request for the transcript, a cancellation request must be made in writing. You will be responsible for payment of any portion of the transcript that has been completed.


