

Dear Ms. Allen:

I am in receipt of your correspondence dated June 12, 2018 and would like to request some clarification of the content. The Order under appeal is dated May 2, 2018 by the Greenville County Clerk of Court. One of the two Notices of Appeal is stamped as received by the "SC Court of Appeals" on May 31, 2018. SCACR, Rule 203(b)(1) proscribes that appeals be filed "within thirty (30) days after receipt of written notice of entry of the order or judgment." That would be without addressing the fact it was then mailed on May 2, 2018 by the Clerk of Court or other anomalies in the filing process of this specific pleading.

A review of the records also finds that a check, bearing "For Order 5/2/18- Hatcher 1810" and "86889" was deposited in the "SC State Treasurer's General Deposit Account (04 Judicial Department)" on June 4, 2018. A copy of such is herewith attached for your review. The request for transcript pursuant to Rule 207(a)(1) was mailed on May 15, 2018. A copy of same is also attached.

Therefore, in preparing the instructed Motion to Allow the Late Filing in this matter I will need some guidance as to which rule was violated so the Court can be informed.

If there should be any other questions or concerns please feel free to advise. As always, your cooperation is greatly appreciated.

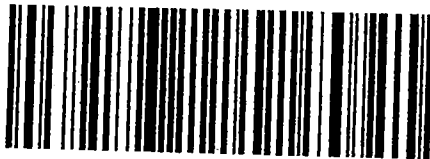

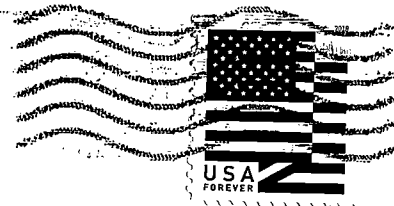
