**AMENDED NOTICE OF APPEAL**

---

Randall Scott Clark appeals the order to register as a sex offender as a part of the sentence imposed by the Honorable R. Scott Sprouse on April 16, 2018, after Appellant's plea to assault and battery 2<sup>nd</sup> degree. After hearing from the State and the defense, Judge Sprouse imposed a sentence of three years, suspended to one year in prison followed by five years on probation. He also issued a "no contact with victim" order and ordered Appellant to register as a sex offender. At the plea Appellant argued against the imposition of sex offender registration as a part of the sentence but did not ask that the trial judge reconsider his sentence.

Appellant requested that an appeal be filed as he was not convicted of a crime listed in South Carolina Code Section 23-3-430(C), good cause was not shown by the solicitor, and no specific findings were made to establish that Appellant should register as a sex offender.
