WHEREFORE, having made Motion to Supplement the Record on Appeal, Respondent


would respectfully request this Court to grant the Motion to include the sentencing sheet and for such other and further relief as this Court may deem just and proper.

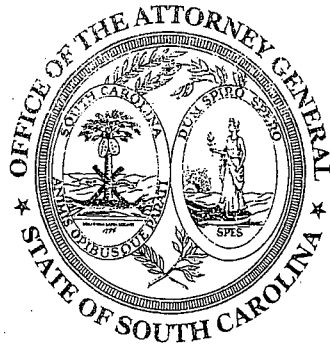
