MOTION FOR AN EXTENSION OF TIME

Counsel for Brandon Bannister respectfully requests a **final thirty (30) day extension, until July 23, 2018**, in which to file the petition for writ of certiorari and appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix are due to be filed with the Court today. The Court has granted counsel two previous extensions.
2. Counsel for Brandon Bannister respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the petition for rehearing in the case of The State v. Antwan J. Jett with the Court of Appeals on May 4, 2018. Counsel filed the brief of petitioner in the case of Michael Ray Elders v. The State with the Court of Appeals on May 3, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Karlin Ramon Foster v. The State with the Supreme Court on May 2, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of James Curtis Tyner v. The State with the Supreme Court on April 26, 2018. Counsel filed the brief of petitioner in the case of The State v. Wayland Purnell with the Supreme Court on April 25, 2018.

4. Counsel makes this request in good faith and not for purpose of delay.


5. Counsel for the Attorney General's office consents to this request as shown by signature below.
