2. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Javan Mays v. State in this Court on June 21, 2018. Counsel



3. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


WHEREFORE, the undersigned counsel would respectfully request a **final thirty-day extension, until July 23, 2018**, in which to file the petition for writ of certiorari and
