NOW COMES Respondent CompTrustAGC of South Carolina a/k/a CompTrustAGC of South Carolina, Inc. (“CompTrust”), by and through its undersigned counsel, pursuant to Rule 263(b), SCACR,¹ and, on the grounds set forth below, hereby moves this Honorable Court for a second extension of fifteen (15) days’ time to petition for rehearing of this matter, which the Court decided via opinion filed May 23, 2018. *See S.C. Prop. & Cas. Ins. Guar. Assoc. v. CAGC Ins. Co.*, Op. No. 5562 (S.C. Ct. App. filed May 23, 2018) (Shearhouse Adv. Sh. No. 21 at 104).

1. Rule 221(a), SCACR, provides, “Petitions for rehearing must be actually received by the appellate court no later than fifteen (15) days after the filing of the opinion, order, judgment, or decree of the court.”

2. Since the Court’s opinion was filed May 23, 2018, the original deadline to petition for rehearing of this matter was the close of business on Thursday, June 7, 2018, i.e., the 15th day after Wednesday, May 23, 2018, as computed in accordance with Rule 263(a).²

¹ Under Rule 263(b), “[t]he time prescribed by the[] [South Carolina Appellate Court] Rules for performing any act except the time for serving the notice of appeal under Rules 203 and 243 may be extended . . . by the appellate court, or by any judge or justice thereof.”

² Under Rule 263(a), “[i]n computing any period of time prescribed or allowed by these Rules, by order of court, or by any applicable statute, the day of the act, event, or default after which the designated period of time begins to run is not to be included[,]” but “[t]he last day of the period so computed is to be

3. On CompTrust's first motion for an extension, the Court, by order filed June 8, 2018, extended the time for serving and filing a petition for rehearing until Friday, June 22, 2018, the present deadline.

4. On account of work-related and other time commitments (including those associated with a recent family vacation from June 12–17, 2018), the undersigned requests that the present deadline to petition for rehearing be extended by 15 days, i.e., from Friday, June 22, 2018, to Monday, July 9, 2018.³

5. The undersigned submits that, under the circumstances, there exists good cause for the Court to grant the relief requested herein, such relief constituting a reasonable dispensation, timely sought, consistent with the interests of justice, and posing no threat of undue prejudice to any other party.

WHEREFORE, CompTrust requests that the Court grant a 15-day extension of the present deadline to petition for rehearing of this matter, i.e., an extension of the deadline to petition for rehearing through July 9, 2018. ADDITIONALLY, CompTrust requests that the Court hold the present deadline to petition for rehearing in abeyance (and not send down the remittitur) until the Court acts on

³ Computed in accordance with Rule 263(a), the last day of the 15-day period of time after Friday, June 22, 2018, is *Saturday*, July 7, 2018; thus, this time period runs until Monday, July 9, 2018, i.e., the “next day which is neither a Saturday, Sunday, nor [legal] holiday.”

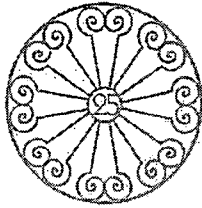

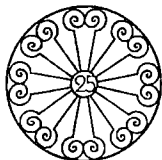
