

The appellant respectfully requests an enlargement of the time to file the initial brief and designation of matter based on the fact the Honorable Judge Joseph Strickland has not ruled on SCRCP Rule 59 (e) motion that was heard May 29, 2018. 

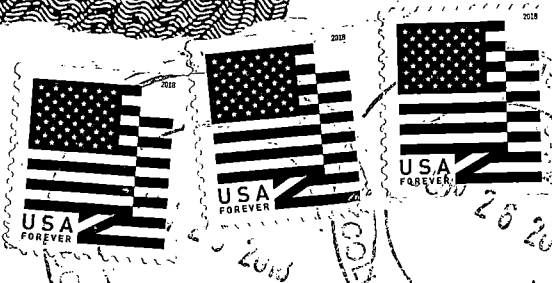
