Thank you for your telephone call this morning. At the time we filed the ex parte appeal for Mr. Cooper, Ms. Fisher had already requested that the court reporter prepare a transcript for the March 2018 bench trial, so we requested a copy. I contacted the clerk's office at the Court of Appeals and was advised that since Ms. Fisher requested the transcript, I did not need to send them a letter that I had requested a copy. I believe that was before Ms. Fisher's appeals were transferred to the Supreme Court. I received a copy on June 11, 2018, as shown in the email from Ms. Lauder below (June 10 was a Sunday, so I didn't get it until Monday). I calculate that our initial brief and designation of the record is due on July 10, 2018. Please let me know if that is not correct or if there is anything else you need from me at this time.
