



These matters are being referred to the Office of Appellate Defense in that we were participating as Court appointed counsel at trial.

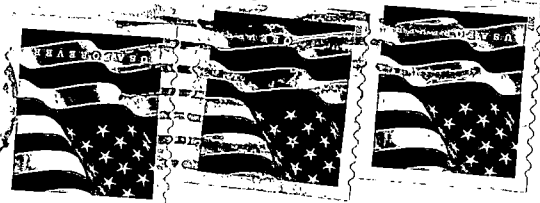
