**APPELLANT’S MOTION FOR COSTS ON APPEAL**

Pursuant to Rule 222 of the Appellate Court Rules of Civil Procedure, Appellant hereby motions the Court for costs and fees to be taxed against Respondent, which shall be taxed when a judgment is reversed. The South Carolina Court of Appeals affirmed the judgment on appeal on March 30, 2016. The South Carolina Court of Appeals denied Appellant’s Petition for Rehearing on June 23, 2016. The Supreme Court of South Carolina granted Petitioner’s Petition for a writ of certiorari to on April 13, 2017. The remittitur was issued by the Supreme Court of South Carolina on June 15, 2018.


