

**MOTION TO FILE OUT OF TIME**

Pursuant to Rules 263 and 240, SCACR, Petitioners move this Court for an Order permitting them to file a Petition for Writ of Certiorari and Appendix out of time. The Petition and Appendix are filed simultaneously with this Motion. The Court of Appeals denied the Petition for Rehearing on June 1, 2018, making the Petition due on July 2, 2018, by Petitioners' calculation. (App. pp. 12, 17). Due to an oversight, the accompanying Petition and Appendix were prepared for filing on July 2, 2018, but it did not occur. Petitioner moves the Court to accept the filing of the Petition for Writ of Certiorari one day later, on July 3, 2018, as timely filed. Pursuant to Rule 263(b), SCACR, the Court may extend the filing time for a Petition for Writ of Certiorari. Respondents will not suffer any prejudice from the one day difference.


