



This matter comes before the Court by way of an application for post-conviction relief filed by JoAnna Marsh ("Applicant") on August 21, 2017. Respondent made its return on or about October 26, 2017. The Court convened an evidentiary hearing into the matter on Monday, May 21, 2018.<sup>1</sup> at the Horry County Courthouse in Conway, South Carolina. Applicant was present at the hearing and represented by James K. Falk, Esq. Johnny Ellis James Jr., of the South Carolina Attorney General's Office, represented Respondent.

Respondent informed the Court that communications with prior PCR counsel Steven W. Fowler, Esq. led Respondent to believe that it had no evidence to contest that Applicant was not timely informed of the entry of the order denying relief in the prior PCR action, and thus was not afforded an opportunity to either request an appeal or knowingly, intelligently, and voluntarily waive her right to an appeal. Respondent then conceded Applicant was entitled to relief pursuant to Austin v. State, 305 S.C. 453, 409 S.E.2d 395 (1991). Accordingly, because Respondent concedes the issue, this Court **GRANTS** Applicant relief pursuant to Austin v. State for appellate review of the order denying relief filed March 10, 2016 (2014-CP-26-01836).


<sup>1</sup> This Court also notes an evidentiary hearing was initiated, but not completed, on Wednesday, February 21, 2018, before the Honorable Steven H. John. The matter was continued at that time, and this Court confirmed Judge John's intention to relinquish jurisdiction with that continuance.

This Court notifies the Applicant that she must file and serve a notice of appeal within thirty (30) days from the receipt by counsel of written notice of entry of judgment to secure the appropriate appellate review. See Rule 203, SCACR. Pursuant to Austin v. State, an Applicant has a right to an appellate counsel's assistance in seeking review of the denial of PCR. Rule 71.1(g), SCRCR provides that if the Applicant wishes to seek appellate review, PCR counsel must serve and file a Notice of Appeal on the Applicant's behalf. Your attention is directed to South Carolina Appellate Court Rule 243 for appropriate procedures for appeal.

**IT IS THEREFORE ORDERED:**

1. Applicant petition for appellate review of 2014-CP-26-01836 pursuant to Austin v. State;
2. Applicant must be remanded to the custody of the South Carolina Department of Corrections.

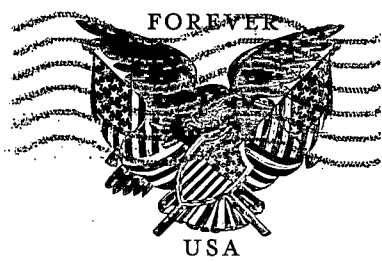
