

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On June 16, 2017 in the Conway section of Horry County the defendant (Symaria Shannon) and a co-defendant did conspire to inveigle the victim to meet them by using the dating website Plenty of Fish. The victim met the defendant at the Walmart located at 151 Myrtle Ridge Dr. where he voluntarily entered the defendants' vehicle under the impression of going to Panera Bread for dinner. Once inside the vehicle the victim was unlawfully seized by the defendant and co-defendant at gunpoint. The victim was forced to get in the back seat of the vehicle where he was driven to the Conway National Bank located at Hwy 544 and Hwy 501. The victim was forced to provide the defendant and co-defendant with the passcode to his debit card where they deprived him of approximately \$500. The victim was then taken to Harper Rd where he was forced to exit the vehicle and shot multiple times. case# 17056045 R/O Britt
