PETITION FOR 15 DAY EXTENSION UNTIL JULY 27, 2018, TO FILE/SERVE
PETITION FOR REHEARING

The Respondents, Erskine College and David A. Norman, pursuant to Rules 221(a), 240, 262(a)(2), and 263(b) SCACR, petition this Honorable Court for an order extending the time to file their Petition for Rehearing by 15 days until Friday, July 27, 2018. This Petition is the Respondents' first request for an extension, is made in good faith and not intended for delay, and is based on the following grounds:

1. On June 27, 2018, the Court issued its opinion in this matter reversing the grant of judgment notwithstanding the verdict in favor of Respondents, and thereby creating a 15 day deadline of July 12, 2018, for Respondents to file their Petition for Rehearing.

2. On June 30, 2018, the undersigned Mr. Close, went on a long-scheduled vacation out of town through July 5, 2018.

3. On July 8, 2018, Respondents' counsel, Mr. Keim, left town for work related-related travel through July 13, 2018, to Nevada for collective bargaining and to Arizona to prepare for arbitration.

4. Thus, during most of the 15 day period since the Court's opinion in this matter, at least one counsel for Respondents has been out of the office, and both have had increased work demands in order to prepare for and/or return from their absences.

In light of the travel, and related work demands, of their counsel, Respondents respectfully request an extension of 15 days to file their Petition for Rehearing, creating a new deadline of July 27, 2018.
