
Appellants/Respondents hereby move pursuant to Rule 263(b), SCACR, for a 30-day extension of the time in which to serve and file Appellants/Respondents' Initial Reply Brief and Designation of Matter to be Included in the Record on Appeal in this case. The grounds for this motion are that there is good cause to grant the requested extension, as the following shows:

1. The deadline for service and filing of Appellants/Respondents' Initial Reply Brief and Designation of Matter to be Included in the Record on Appeal is today, July 9, 2018.
2. This is the first extension of this deadline that Appellants/Respondents have sought in this appeal.
3. Appellants/Respondents' counsel has not yet been able to complete the reply brief. The undersigned counsel was out of the office for a good portion of last week in connection with the Fourth of July holiday. The undersigned has multiple hearings that are presently scheduled for this Wednesday, July 11. Also, the undersigned was recently engaged to submit an amicus brief and motion for leave to file it in the Supreme Court and has had to spend time drafting that brief on an expedited basis due to the posture of that Supreme Court case.
4. Further, Appellants/Respondents' counsel has recently found a line of research that appears relevant to the issues presented by both Respondent/Appellant's respondent's brief and Respondent/Appellant's appellants' brief in this cross-appeal, and he needs time to develop that research and incorporate it into the briefs.

5. The Appellants/Respondents' reply brief in this cross-appeal and respondent's brief in this cross-appeal are presently due two days apart, and Appellants/Respondents are concurrently moving for a 30-day extension of time of the other brief's deadline as well. This seems appropriate, as the undersigned counsel expects that there will be significant overlap in the matters discussed in those briefs.
6. Appellants/Respondents' counsel believes there is good cause to grant the requested 30-day extension to August 8, 2018.

WHEREFORE Appellants/Respondents pray for an order extending the time in which to serve and file their Initial Reply Brief and Designation of Matter to be Included in the Record on Appeal to August 8, 2018.


