MRI Brain with Contrast 11/13/2017:

TECHNIQUE:

Sagittal T1-weighted axial T2*, diffusion weighted, T1-weighted, and T2-weighted images were obtained with axial and coronal FLAIR whole brain images obtained. Axial and coronal T1-weighted images were obtained after intravenous administration of 7 mL Gadavist

COMPARISON:

CT head 10/25/2017

HISTORY:

Left facial droop and left-sided weakness began approximately 3 weeks ago.

FINDINGS:

Brain parenchyma: An ovoid area of FLAIR T T signal abnormality is noted in the far lateral aspect of the thalamus and adjacent posterior limb of the right internal capsule. Likely this is a deep white matter infarct. The marrow enhancement is seen after contrast administration. There is no convincing evidence of restricted diffusion. In addition numerous much smaller lesions are identified scattered throughout the cerebral white matter likely indicative of areas of gliosis from chronic small vessel ischemic insults.

After contrast administration there appears to be normal cortical venous and dural enhancement without pathologic leptomeningeal or parenchymal enhancement identified.
