**MOTION TO ENLARGE TIME FOR INITIAL BRIEF**



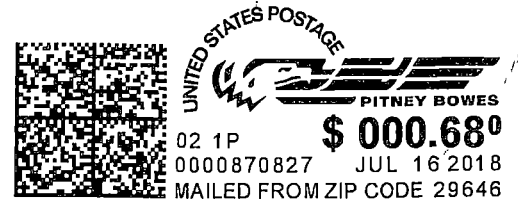
