**MOTION FOR EXTENSION OF TIME**





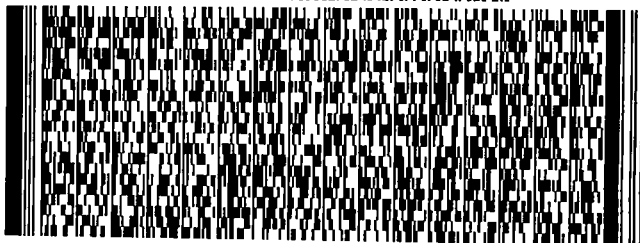
