

ORDER

This appeal arises out of a circuit court order compelling the parties to participate in arbitration. "In an arbitration case, the only appeals that may be taken are from an order of the circuit court enumerated in section 15-48-200." *Steinmetz v. American Media Servs., LLC*, 393 S.C. 72, 74, 709 S.E.2d 708, 709 (Ct. App. 2011); S.C. Code § 15-48-200(a) (2005) (setting forth the types of appealable arbitration orders). Because an order granting an application to compel arbitration is not enumerated in section 15-48-200, this appeal is dismissed as not immediately appealable. The remittitur will be sent as provided by Rule 221(b) of the South Carolina Appellate Court Rules.
