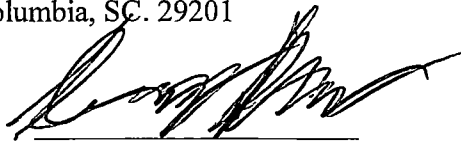

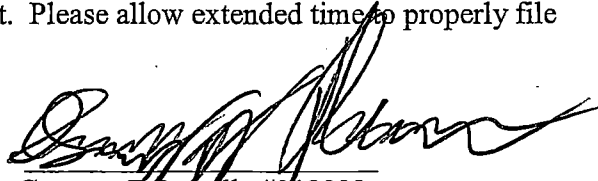

Dear Ms Kitchens;

It is obvious that my layman's understanding of this Court's proceedings are lacking. 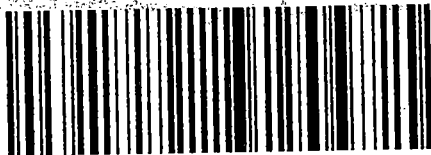
