
COME NOW APPELLANTS, C. Gordon Lovingood, Jr., C3 Investments, Inc. and PPC12, LLC, through undersigned counsel, and who hereby move this Honorable Court, pursuant to Rule 263(b), SCACR, for an Extension of Time to file a Petition for Rehearing.

Rule 221, SCACR requires Respondents' Petition for Rehearing to be received by the Court of Appeals on or before July 12, 2017. 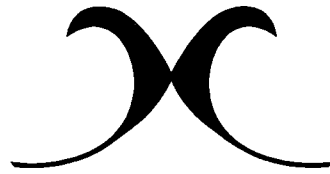

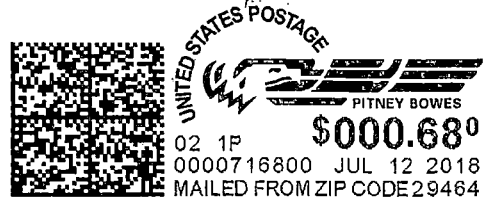
