Petition to Extend Time to File Petition for Writ of *Certiorari* and Appendix

Jennifer McSharry, petitions this Court to extend the time to file the petition for writ of certiorari and appendix until Monday, August 20, 2018. This is the third request for an extension. This request is based on the follow grounds.

1) Counsel is a solo practitioner with a statewide trial, appellate, and post-conviction practice. Since the beginning of May 2018, counsel's workload has included:

- Preparing for and trying the evidentiary hearing in *Sammie Lee Gerrick v. State*, Aiken County Case Number 2016-CP-06-00111, involving a murder conviction. Counsel also submitted a post-hearing brief, requested by the PCR court, on June 15, 2018, and a reply to the State's post-hearing brief on June 20, 2018.
- Filing the Initial Brief of Appellant in *State v. Plumer*, Court of Appeals Appellate Case Number 2017-00481.
- Filing the petition for rehearing in *State v. Michael Beaty*, Appellate Case Number 2015-000718.

- Jury trial for the week of May 21, 2018 in *State v. Charles Dent*, Beaufort County Case Numbers 2014-GS-07-01671 to 01674, a first-degree criminal sexual conduct case.
- Filed the petition for writ of certiorari in *Joseph Graddick v. State of South Carolina*, Appellate Case Number 2018-000193.
- Preparing the Record on Appeal in *J.R. Jones, v. S.C. Republican Party*, appellate case number 2017-002583, an election case expedited by this Court.
- Preparing a Petition for Rehearing in *State v. Preston Shands*, Court of Appeals Case Number 2015-001195.
- Filed the petition for writ of certiorari and Appendix in *Jerome J. Noone v. State of South Carolina*, Appellate Case No. 2018-000095.
- Preparing the Appendix and petition for writ of certiorari to review the Court of Appeals decision in *State v. Nikia Johnson*, Court of Appeals Case No. 2015-001436, which is due on Monday, July 23, 2018 and takes priority under this Court's procedures for petitions for writs of certiorari to review decisions of the Court of Appeals




