FACTUAL BASIS AND WRITTEN EXPLANATION OF ISSUES ON APPEAL

Ralph Wilson, Jr., attorney for Appellant during his guilty plea, provides the following factual basis and written explanation of issues on appeal pursuant to Rule 203(d)(1)(B)(iv) of the South Carolina Appellate Court Rules for the filing of Notice of Appeal on behalf of Jason Kyle Sherman:


On or about February 15, 2017, Appellant was arrested and charged with Hit and run, duties of driver involved in accident with death; Driving under suspension, Simple possession of marijuana, Possession of drug paraphernalia, and Transporting alcohol in motor vehicle with seal broken. An offer was extended by the State for the Defendant to plead guilty to the charge of Hit and run, duties of driver involved in accident with death for a recommended sentence of 12-18 years with a deadline to accept of May 30, 2018. A hearing regarding Attorney Wilson's Motion to be Relieved as Counsel, filed April 9, 2018, was also scheduled for May 30, 2018. During the

hearing, Counsel withdrew the Motion to be Relieved and the Appellant entered a guilty plea with sentencing deferred until June 13, 2018. The guilty plea was accepted by the Court. During sentencing on June 13, 2018, the Court imposed a sentence of fifteen (15) years. Warrants for Driving under suspension, Simple possession of marijuana, Possession of drug paraphernalia, and Transporting alcohol in motor vehicle with seal broken were dismissed as part of the plea.

Appellant requested a Notice of Intent to Appeal be filed on his behalf. The Notice of Intent to Appeal was filed and served on behalf of Appellant on June 19, 2018.

The reasons stated above and any other reasons Appellant has for filing the action are the subject of this appeal.


