MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for appellant respectfully requests an extension of thirty (30) days in which to file the petition for writ of certiorari and appendix in this case. previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.



Counsel filed the petition for writ of certiorari and accompanying appendix in the case of The State v. Gerald Rudell Williams with the Supreme Court on June 21, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of William Ricky Welch v. The State with the Supreme Court on June 18, 2018. On June 12, 2018, counsel had an oral argument in the case of Darrell L. Goss v. The State before the Supreme Court. On June 7, 2018, counsel had an oral argument in the case of The State v. Michael Juan Smith before the Court of Appeals. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of David Mario Johnson v. The State with the Supreme Court on May 30, 2018.

4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request.




