Norman, pursuant to Rules 221(a), 240, 262(a)(2), and 263(b) SCACR, petition this Honorable Court for an order extending the time to file their Petition for Rehearing by 15 days until Monday, August 13, 2018. This Petition is the Respondents' second request for a 15 day extension, is made in good faith and not intended for delay, and is based on the following grounds:


1. On June 27, 2018, the Court issued its opinion in this matter reversing the grant of judgment notwithstanding the verdict in favor of Respondents, and thereby creating a 15 day deadline of July 12, 2018, for Respondents to file their Petition for Rehearing.

2. On July 10, 2018, Respondents filed their first Petition for 15 Day Extension Until July 27, 2018 to File/Serve Petition for Rehearing based on counsel for Respondents' pre-planned travel and consequent high-volume work demands, which the Court granted on July 11, 2018.

3. Counsel for Respondents have continued to experience a heavy volume of

work demands and therefore respectfully request a second extension of 15 days to file their Petition for Rehearing, creating a new deadline of August 13, 2018.





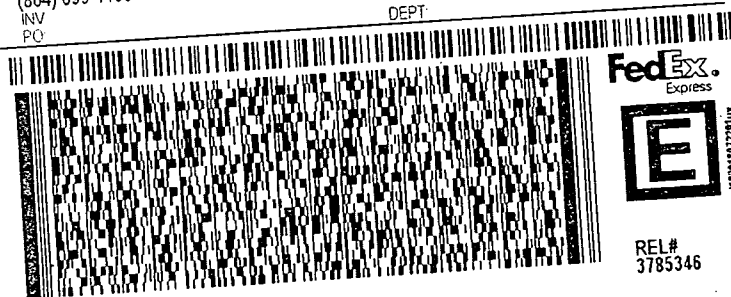
