This is Lakessiah Henderson. I was not aware that there would be any issue with my power of attorney Kelly Owens Power of attorney falling for me.

I also did not receive a copy of the order explaining why my filing was not accepted. I've only recently found out as to why. I'm making sure that this information is being filed to the court by me at Great risk to my own health.

Motion to reconsider
No additional fees are due for this motion or previous. I move the court to reconsider the motion to reconsider (June 8) and motion to dismiss. Motion to reconsider should have been ruled on as no payment was necessary, (despite Claire Allen false statements) otherwise because a motion to proceed without fee was filed with
I move that the court allow accommodations for Lakessiah Henderson s disabilities, such as extension of time.

To stop Landlord harassment and retaliation
The Court was previously asked via motion to dismiss to stop Kim Henderson retaliation and harassment. The judges chose not to without any explanation. As a result Lakessiah Henderson health has worsened. I move the Court to order Landlord and others to stop retaliation, harassment, and harm to health.

Motion to accommodate for disability

I move for the Court to accommodate Lakessiah Henderson for disabilities including but not limited to extension of time.

Motion for extension of time for ordering transcript.

Lakessiah Henderson has had to contact outside organizations and authorities to assist with protecting her from harmful acts by landlord Kim Henderson and others in residence. For example, Kendrick Henderson (Kim Henderson's son) recently committed assault against Lakessiah Henderson. He has also played a role in worsening her health by refusals to accommodate her disabilities. This has consumed the time which could have been used to order transcript.

No transcript was available for May 22, 2018. Communicated with court reporter in regards to transcript. Cannot give a transcript that doesn't exist.

In fact this is proof of the secret hearing by Judge Stilwell that informed court about in Motion to Dismiss, where I was never given notice.

My motion was denied in entirety without any explanation or law to back it up and a bond hearing Magistrate court due to failing of Court of Appeals.

Judges stillwell, motion to dismiss, bond hearing, additional lawsuits, attending to declining health due to landlord and Court of Appeals negligence absorbed the time.

Motion to stop remitter

The case is currently in federal court so it should not and cannot be remitted to smaller court.

Also Ms. Henderson is in litigation with judges of lower court, which would be a conflict of interest.

Ms. Henderson is also in litigation with judges of Court of Appeals, and Claire Allen.

Order of dismissal was signed by Clair Allen, not a judge. She is attempting to function as a judge.

She has also lied and accused Ms. Henderson ex parte communication via email even though the Court which put by email first. They have also accepted documents via email.

Motion for rehearing

I demand rehearing of case due to the evidence being brought to light in regards to Judge Stilwell transcript and pattern cases where the party isn't present. For a prior case before appellate court he had hearing after being informed I was in the hospital.

Also due the impropriety and violations of law from Claire Allen and Judges. Note conflict of interests and Federal litigation.

If any deficiency is found hearing allow enough time to correct before the denying.

Motion to stay writ of ejectment

Also this is a motion to stay writ of ejectment to take place on July 26th. Lakisha Henderson was given a writ of ejectment by Magistrate Court on July 25th as a result of not being allowed the proper time to correct deficiencies.
