As PCR counsel I filed a notice of appeal in the above case. I have taken the appropriate steps to engage SCCID Appellate Division in the appeal of the case. SCCID has requested Mr. Chapman provide additional information regarding his mortgage balance. I have made sure Mr. Chapman is aware of the need for him to obtain that information and send it to SCCID. It is my understanding that Mr. Chapman is doing what he needs to do to allow SCCID to complete the analysis of his eligibility for its services. My representation does not extend to the appeal of the case and therefore I intend to take no further action unless directed to do so. In the event that SCCID is unable to engage then I will inform Mr. Chapman that he must retain counsel and I will move to be relieved.

I have been informed by SCCID that its analysis of eligibility is on hold pending receipt of further information from Mr. Chapman. I am therefore requesting that the time for ordering the transcript be stayed or extended to allow Mr. Chapman to obtain the requested information and mail it to SCCID so that it can complete the eligibility analysis.

By copy of this letter I am reiterating to Mr. Chapman the need and importance of his obtaining and providing to SCCID whatever information has been requested.

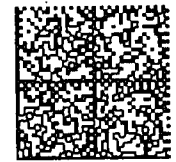
