See, e.g., *U.S. v. Livarsi*, 180 F.3d 76, 82 (2d Cir. 1999)

(plea invalid) because court failed to determine at plea hearing whether defendant was under influence of medication or drug.

I told Judge Miller at Guilty plea I was getting Haldol Injections and other mental health medications, he didn't bother to check but went ahead with plea.

*U.S. v. Cole*, 813 F.2d 43, 46 (3d Cir. 1987) (plea invalid) cause court failed to make further inquiry into competency after statement defendant took drugs/medication before plea hearing. - its on guilty plea transcript I told judge Miller I took mental health meds before plea.

*U.S. v. Damon* 191 F.3d 561, 564, 65 (4th Cir. 1999) plea invalid - cause court did not make further inquiry into competency after learning defendant under influence of medication listing (impaired judgement) as side effect.  
< *Burt. v. Uchtman* 422 F.3d 557, 586 (7th Cir 2005)

*Stafer v. Bowers* 329 F.3d 637, 648-51 (4th Cir 2003) - plea invalid - because court should have conducted competency hearing after learning of defendant's use of psychotropic medications. The judge and public defender was aware of this at my plea

Mo* 420 U.S. 162, 178-83 (1975) - courts failure to make sufficient inquiry into defendant's competence and give adequate weight to defendant's suicide attempts and other irrational behavior violated due process - my public defender knew I attempted suicide in the county jail a couple times and the victim and my family told her I've had mental health problems my hole life, and she had the police reports where they had me in the hospital under physc. Doctor Staeners orders for me to be sent to Patrick B. Harris mental Hospital til Greenville police had the Greenville hospital Release me so they could arrest me,

See also *Pate v. Robinson* 386 U.S. 375, 385-86 (1966) - courts failure to conduct competency hearing in light of defendant's pronounced irrational behavior violated due process

*U.S. v. Jones*, 495 F.3d 274, 277 (6th Cir 2007) due process violated - by failure to conduct a competency hearing for defendant with history of mental health problems, delusions, hunger strikes, and suicide attempts. I have paper work from mental health socc doctors where I've had all these problems.

*U.S. v. Collins* 430 F.3d 1260, 1269 (10th Cir 2005) new trial ordered after court improperly denied defendant request for competency hearing, my public defender denied me this request before my plea she only met me 3 times in person.
