DESIGNATION OF MATTERS TO BE INCLUDED IN THE RECORD ON APPEAL

July 23, 2018

To All Parties To The Appeal:

Rule 209(a)-(c), SCACR, clearly states the following in pertinent parts: **(a)** “[A]t the same time a party serves his initial brief(s) under Rule 208, to include a reply brief, he shall also serve on all parties to the appeal a Designation of Matter to be Included in the Record on Appeal which shall set forth with specificity those parts of the transcript, pleadings, orders, exhibits, or other materials which he proposes to include in the record on appeal. One copy of this Designation with proof of service shall immediately be filed with the clerk of the appellate court.”

(b) “[T]he Designation must clearly identify what the party desires to have included in the Record on Appeal, and the Designation may only propose to include portions of the transcript, pleadings, orders, exhibits, or other materials which may be properly included in the Record on Appeal [See Rule 210(c)]. A party shall not include any matter in his Designation which is not relevant to the appeal. **(c)** “[T]he Designation shall be accompanied by a certificate signed by the party’s counsel of record that the Designation contains no matter which is irrelevant to the appeal.”

In order to save time, money, effort and to expedite matters relative to my appeal and pursuant to Rule 209, SCACR, please send me a list of all the matters you want in the Record On Appeal. Since, I have to pay for all this, it would help me plan my finances more proficiently, effectively and efficiently. I still have living expenses that must be paid in a timely manner. By assembling your list in advance, it would help all of us avoid unnecessary and costly duplication during the appeal process. As soon as I receive your list of matters, I will send you mine if necessary. Your list might be all that is required for the Record on Appeal. Thank you in advance for acting on my request.
