GIVING FALSE INFORMATION TO POLICE OFFICER

ON THE ABOVE DATE AND TIME CPL NIX WAS DISPATCHED TO WALMART FOR A SHOPLIFTER. WHILE ENROUTE TO WALMART DISPATCH ADVISED THAT A WHITE MALE SUSPECT WAS LEAVING IN A GREEN CAR GOING INTO MURPHY'S. PSO YOUNG AND PSO CANUPP GOT OUT WITH A WHITE MALE IN THE PARKING LOT OF MURPHY'S. THE OFFICERS ASKED THE WHITE MALE HIS NAME THE WHITE MALE STATED BRIAN SMITH AND THAT HE HAD NO ID. CPL NIX AT THAT TIME WENT AND SPOKE WITH LPO OF WALMART RUSS BENTLEY. MR. BENTLEY STATED THAT THE WHITE MALE ENTERED THE STORE SELECTED SOME ITEMS. MR. BENTLEY THEN STATED THAT THE WHITE MALE WENT AND SELECTED SOME HEAD PHONES. THE WHITE MALE THEN WENT TO THE SERVICE DESK AND RETURNED THE HEAD PHONES WITH AN OLD RECEIPT WITH THE SAME ITEM ON IT. THE STORE EMPLOYEE GAVE THE MALE MONEY BACK DUE TO HE HAD PRESENTED A RECEIPT WITH THE ITEM. MR. BENTLEY STATED THAT HE WATCHED THE MALE SELECT THE HEAD PHONES AND GO TO THE SERVICE DESK. MR. BENTLEY STATED THAT HE WASN'T SURE AT THAT TIME WHAT THE MALE WAS UP TO. AFTER THE MALE RECEIVED THE MONEY MR. BENTLEY WENT AND ASKED THE EMPLOYEE WHAT HAPPEN. MR. BENTLEY STATED THAT THE EMPLOYEE INFORMED HIM THAT THE MALE PRICE CHECK SOME ITEMS AND GOT A REFUNDED ON SOME HEAD PHONES. MR. BENTLEY KNEW THAT THE MALE HAD JUST SELECTED THE HEAD PHONES CALL THE POLICE AND WATCHED WHERE HE WENT ONCE HE LEFT THE STORE WITH THE MONEY. MR. BENTLEY SHOWED THE VIDEO TO CPL NIX WHERE HE SEEN THE MALE SELECT NEW MERCHANDISE AND RETURN IT AS IF HAD ALREADY PAID FOR IT. CPL NIX WENT TO MURPHY'S WHERE YOUNG AND CANUPP HAD THE WHITE MALE.
