
Dear Mr. Sumner:

I hereby acknowledge receipt of your request for transcript dated May 15, 2018 in the above-captioned case held in front of Judge Young on January 22 - February 2, 2018. We are in receipt of your correspondence dated July 24, 2018, concerning the trial transcript and requesting an update on the status of the appeal. We received reply correspondence from the court reporter, Ms. Haffenden, dated May 29, 2018, indicating that the 60 day time frame for completion of the trial transcript would begin upon her receipt of payment.
