## ORDER

---

On June 13, 2018, this Court granted appellants' motion to expedite this appeal and stated it would set an expedited briefing schedule once all relevant transcripts were received. On July 20, 2018, appellants notified the Court that all relevant transcripts have been received.<sup>1</sup>

The time for filing the initial briefs and designation of matter to be included in the record on appeal pursuant to Rule 208(a), SCACR, shall be shortened to twenty days for appellants' and respondents' briefs and five days for any reply brief. The time for serving the record on appeal shall be shortened to five days. The time for serving and filing final briefs, along with the time for filing the record on appeal with this Court, shall be shortened to five days. Due to the shortened time periods provided by this order, the parties shall, in addition to serving any document in the manner required by Rule 262(b), SCACR, e-mail a copy of the document to the opposing counsel or party by the due date. If necessary to allow the record on appeal to be e-mailed, the record on appeal may be broken into separate parts, with the parts being e-mailed sequentially. Oral arguments in this case will be heard in

the first term of November on the same day as those in *Ex parte Cooper*, Appellate Case No. 2018-000662, and the same month as the submitted case *Fisher v. Huckabee*, Appellate Case No. 2017-000743, both of which have been placed on identical briefing schedules.<sup>2</sup> No extensions will be granted absent a showing of extraordinary circumstances.
