THE ISSUING JUDGE WITHIN 10 DAYS OF THE NOTICE OF RECEIPT.

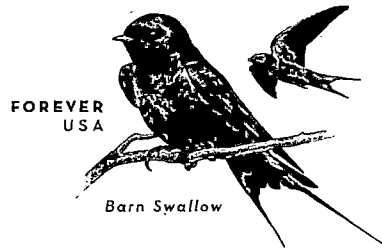
