NOTICE OF APPEAL

I hereby appeal the order (herewith) of Administrative Law Court Judge Milton G. Kimpson dated July 23, 2018 and received by me July 27, 2018 because he committed an "error of law," S.C. Code §§ 1-23-380 (s)(d) and 1-23-610(B)(d), where he ordered the respondent to, when considering me for Supervised Furlough pursuant to S.C. Code §24-13-710 (Supp. 2017), take into account any disciplinary convictions subsequent to my parole eligibility date of November 28, 2017, when S.C. Code §24-13-710 (Supp. 2017) clearly indicates that the respondent must take into account my disciplinary record only six (6) months prior to my parole eligibility date. See Williams v. Peyton, 372 F.2d 216, 220 (4th Cir. 1967) (finding that the lower court was supposed to order an evaluation of the prisoner's behavior at the time of trial, not any subsequent behavior). Accordingly, I request Judge Kimpson request this case be remanded back to him in order for him to correct his order, or, that this court remand this back to him themselves in order for him to do so. However, because I believe Judge Kimpson is a most honest and responsible person and judge, see Order finding that I was indeed eligible for furlough, I believe that he will most likely beat the court to the punch.²





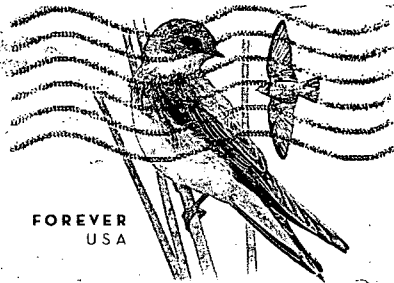
