you.

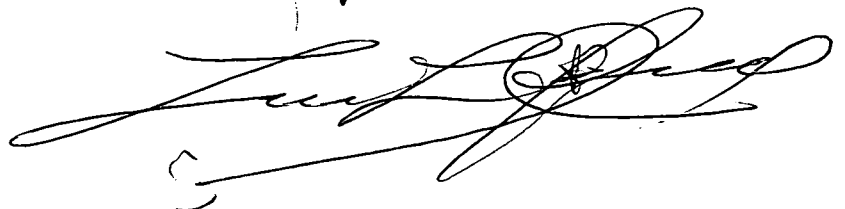
