

I am available to discuss this case if you so desire.

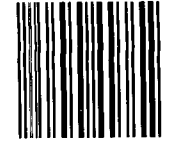

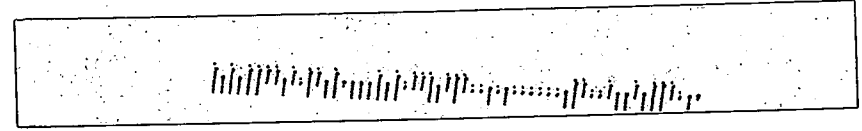
