I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On 4/3/17 Inv. Evenson observed defendant at 110 Pepper Hill Way Aiken, SC in Aiken County, SC looking into parked vehicles. The defendant was also observed looking into cars at neighboring businesses. Inv. Evenson observed the defendant's pants pockets to appear very heavy with items. Contact was made with the defendant and a terry frisk was conducted to ensure officer safety. During the search, several knives, an unknown brown substance and a pill bottle labeled Alprazolam (generic Xanax) were found on the defendant's person.
