Dear Ms. Allen:

Please consider this my Return to Mr. Hunter's Motion to Intervene and Motion for 10 days to respond to Appellant's Motion dated July 26, 2018. Based on our Motion to correct the caption and based on Mr. Hunter's Motion, I hereby consent on behalf of myself and my fellow appellant Mr. John M. Milling, to the Motion filed by Mr. Hunter. If I need to file a more formal return, please let me know. As to his three (3) reliefs requested:

First, Mr. Hunter and I both agree that the caption should have included the Commission as the Respondent. As set out in our Motion we believe our appeal was properly captioned or alternatively the caption should read per the example in reference to an appeal from the decision of an administrative agency as set out in the Rules of the Court.

Second, as I have previously advised the Court, I had not received notification of Counsel of Record for the Commission and it is my understanding from the Motion that Mr. T. Parkin Hunter and Ms. Harley Littleton Kirkland, will be representing the Commission in the appeal.


Third, I have absolutely no objection to Mr. Hunter and Ms. Kirkland being given 10 days to reply to my Motion.



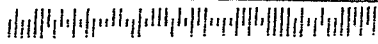

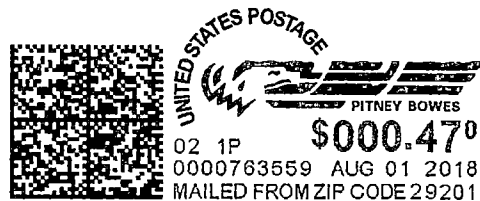
