

NOTICE OF APPEAL

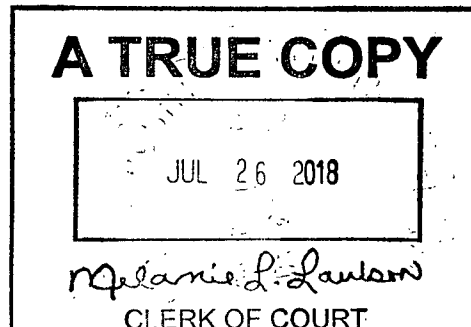

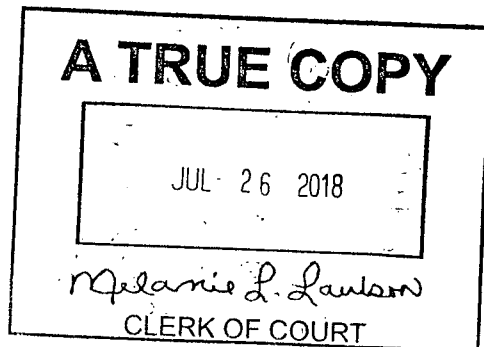


Dear Ms .Kitchings:

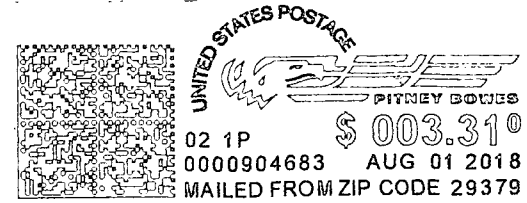
He was sentenced by the Honorable Daniel D. Hall.
