

PETITION FOR EXTENSION



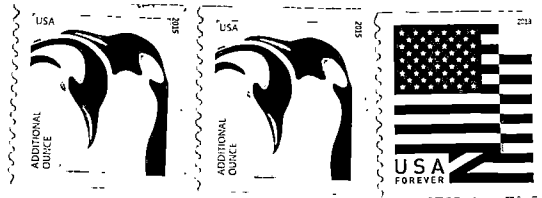
