NOTICE OF APPEAL

Demarco Johnson appeals the Court of General Session's Order of Dismissal filed June 26, 2018 for his Motion for Re-Sentencing pursuant to *Aiken v. Byars*, 410 S.C. 534, 765 S.E.2d 572 (2014) and life without the possibility of parole sentence on indictments 2000-GS-40-47714, 2000-GS-40-47716, 2000-GS-40-47717, 2000-GS-40-47718.

Appellant filed a motion on July 1, 2016 for resentencing pursuant to *Aiken v. Byars*. Chief Justice Pleicones ordered that the Honorable R. Knox be vested with exclusive jurisdiction over Appellant's Motion for Re-sentencing. Appellant's case was appointed to the Richland County Public Defender's Office and assigned to J. Taylor Bell, Assistant Public Defender. Counsel for Appellant filed a Memorandum in Support of Motion for Re-Sentencing on May 25, 2017. Respondent filed a Motion to Dismiss on May 25, 2017. Appellant's case came before the




