

NOTICE OF APPEAL

Danny Ray Pittman appeals his conviction and the sentence imposed by the Honorable G. Michael Nettles. On December 20, 2012, the Appellant pled guilty under Alford to two counts of Assault and Battery of a High and Aggravated Nature. The Appellant received consecutive sentences of twenty (20) years on Indictment No. 2012-GS-46-4375 and five (5) years on Indictment No. 2012-GS-46-4376. The Appellant also pled guilty under Alford to Grand Larceny (Indictment No. 2012-GS-46-4376) and received a sentence of five (5) years. This five year sentence is to run concurrent to Indictment No. 2012-GS-46-4374).


