We recently received a copy of the Record on Appeal from the Appellant Harold Estes Blackwell, Jr. dated July 17, 2018. Pursuant to Rule 210, SCACR, “[t]he Record on Appeal shall include all matter designated to be included by any party under Rule 209 and shall comply with the requirements of Rule 267.”


- Motion for Leave to Proceed in Forma Pauperis, June 8, 2017;

- Order Granting Fisk’s Motion to Dismiss, November 8, 2017;
- Order Granting Miller’s Motion to Dismiss, November 8, 2017; and
