MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION
FOR WRIT OF CERTIORARI AND APPENDIX

Counsel for Anthony Derone Richardson respectfully requests a **final thirty (30) day extension, until September 12, 2018**, in which to file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today. The Court has granted counsel two previous extensions.
2. Counsel for Anthony Derone Richardson respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Preston Morse v. State in this Court on June 25, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Javan Mays v. State in this Court on June 21, 2018. Counsel argued in the case of State v. Joe Ross Worley in the South Carolina Court of Appeals on June 20, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Sherman Myers v. State in the Supreme Court on May 29, 2018.


4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request as shown by signature below.




