Dear Madam Clerk:

In response to Attorney's Motion to Dismiss the above referenced Appeal, because of failure to include certain documents of the Respondent in the Record on Appeal, I would submit the following in contention to the same.

- Respondent did not provide the South Carolina Highway Patrol MAIT Report until the middle of July 2018 after our many requests for the same.
- There is no document of Order Appointing Personal Representative of the Estate of Harry Washington for March 30, 2017 and March 31, 2017. This became quite baffling until the Probate Court finally shed light that the Judge of Probate Court issues a Certificate of Appointment which is tantamount to the Order(s) the Respondent is referencing.
- On Respondent's Designation of Matter it lists the document referred to as Creditor's Claim of April Mack against the Estate of Barrett D. Mack we have spent considerable time trying to locate this document only to learn that the same does not exist. This was revealed to us the date of this letter.

Accordingly, the Respondent's hands are not clean in this matter and I would ask the Court to deny Respondent's Motion to Dismiss this Appeal and allow us Appellant until August 24, 2018 to amend/supplement the Record on Appeal to include the MAIT report and other tantamount

documents that have been misnomers by the Respondent in her Designation of Matter to be included in the Record on Appeal. Also, please allow this letter to serve as a return to Respondent's request of dismissal of this appeal. Further, Appellate's Counsel has tried to resolve this matter with Respondent's attorney by providing the information, but to no avail.

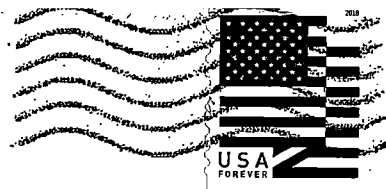
